8. <u>2014. TO RECEIVE FEEDBACK FROM COUNCILLORS RE: CONSULTATIONS/DRAFT DOCUMENTS/MEETINGS RAISED AT LAST MEETING</u>

1. Wrexham Community South Safety Meeting – Cllr Ralphs advised the members that some Police Officers are available to give talks on drugs to youths in the area, this could include visiting Scout Groups – with parents also invited to attend.

Accessibility of Police stations was discussed and the necessary safety issues to be considered. The Division is short staffed at present, through illness and not having the full quota of staff. This will be reviewed in the future. Wrexham South has the best reduction of crime statistics in North Wales.

Wrexham County Borough Council fund £60,000 towards the training of PCSOs. Sergeant Darren Whibberley is leaving and will be replaced by Sergeant Chris Griffiths.

The PCSO who covers Erbistock has been awarded the High Sheriff's Award for services above and beyond the call of duty.

A cannabis factory has been found and destroyed at Newbridge.

2. Town and Community Council Forum – Cllr Kember gave updates regarding gritting and salting during bad weather, fibre to the cabinet (Broadband connection) and improving communications between local service boards. Cllr Kember advised the meeting that funding for carbon emission and energy use reduction may be available through Wrexham County Borough Council.

Action: The Clerk to contact Steve Jones regarding funding availability.

- 3. Wrexham low carbon community challenge Cllr Dodwell informed the members that two expressions of interest had been submitted solar powered conversions for homes/businesses throughout the community and a feasibility study into harnessing the power of the River Dee to offset carbon emissions of the community.
- 4. Local Government Boundary Commission for Wales electoral review of Wrexham Tuesday 16th February the review is being carried out across Wrexham. The Clerk believed that no changes would be made to the Overton community.
