A criminal damage incident took place at Rhewl Farm, Knolton Bryn overnight 14th of September. Unknown offenders have entered the insecure dairy and have smashed a number of large milk bottles and associated piping.

A theft of concrete planters, which took, place 21st of September from a property at the Old School Mews.

Both incidents are undetected at this time.

A road traffic collision was reported 17th of September on Wrexham Road between a HGV and a small car. Damage only but the driver of small car was responsible due to being on his mobile phone at the time.

Criminal damage to a residence took place between 8th and 9th October. A youth was arrested.

In reference to the parking on pavement issue which was brought to my attention at the last meeting;

There has been a rise in complaints from residents about this matter throughout the village. We understand that in some situations residents park their vehicles half on the pavement in order to allow traffic to flow through freely. We also know residents park like this in order to ensure their vehicle is safer from passing motorists especially the HGVs, which travel through the village. The law states that by parking on a pavement you are causing an obstruction in two ways either unnecessary or wilfully. The Police have requested a representative from Wrexham Council accompanies them on a walk around the village to assist in advising residents on the dangers and implications on parking on pavements. We know that visitors and workers in the village are also parking in this way and we will be hopefully tackling the problem in due course.

8. <u>2109. TO RECEIVE FEEDBACK FROM COUNCILLORS RE: CONSULTATIONS/DRAFT</u> DOCUMENTS/MEETINGS RAISED AT LAST MEETING

- 1.Wrexham Community South Safety Meeting Cllr Burton advised that Crimes for Overton in September totalled 3, this compares with 30 for Rhos! Overall crime figures for Wrexham South were down 9.1%. Thefts and assault down 26%, vehicle crime down 34% and burglary from dwellings down 12.5%. Criminal damage was up 4% and the police are targeting persistent criminals. CBM's and PCSO's were looking at the root causes of criminal damage and although anti social behaviour stats are down 4% Sgt Griffiths is keen to identify young people who are causing low level trouble who have not yet in the Criminal Justice System so that police can approach parents before their children become a problem.

- 3. Consultation on Local Planning Guidance Note no 31 Cllr Maskall gave a brief outline to the consultation.
- 4. Shropshire Council Statement of Community involvement for Shropshire consultation document Cllr Maskall reported on the document and its content.
- 5. Town and Country Council Forum meeting Cllr Maskall gave feedback from the meeting: The Flintshire Charter is due to be distributed to members. The 2011 Census will be carried out on 27th March. The discussion regarding the opening of the Wrexham centre public toilets is still under discussion. Wrexham Council are looking to save £30.3 million over the next three years.
