- Feedback regarding the setting up of an under 11 football team This item was deferred to the January meeting.
- Inspection of Playingfield equipment and required maintenance Cllr Lynch advised the meeting that a second visual inspection of the play equipment had been carried out and that no major problems had been noted. It was agreed that a weekly visual inspection would be carried out and any problems would be noted and reported to the Clerk.
- Consideration to continue the payments for the Youth Club hire of Scout Hut facilities for 2013/14 39 weeks at £15 = 585.00 Proposed by Cllr Kember, seconded by Cllr Minihane all in favour.
- Consideration to methods to improve tree/s in Millenium Meadow to prolong life.
 - Members read the recommendations from Moray Simpson, M.Abor.A, at Wrexham County Borough Council. The suggestion was for fresh wood chip to be spread at the crown of the tree and for a solution of sugar mixed in water to be added to the roots during the growing season. This would, hopefully, prolong the trees life and reduce the cost, as felling the tree would be more expensive. **Proposed Clir England, seconded by Clir Minihane all in favour.**
- Update from initial work carried out by 'Sunflowers' working party quotes and artists impressions for the play equipment at the Playingfield were viewed and a lengthy discussion took place regarding the project. Members approved the following to move the project forward:
 - o In view of the funding and consultation required a new committee will be set up in January. The committee will consist of three Councillors and members of the 'Sunflower' group.

- A full and comprehensive consultation will take place which includes residents of Overton, landowners and any other interested parties identified by the committee.
- Consider and approve Precept for 2013/14 Community Councillors discussed the proposed precept in detail. The final figure agreed and approved for the financial year of 2013/2014 was £31,424.00. The Council were able to reduce the precept significantly as previously proposed expenditure which had not been used has been reallocated.
- Consider Clerk's pay increase for 2013/14 Councillors put forward an increase of 1% for the Clerk's wages as of April 2013. **Approved by members.**
