Inspection of Garage – this has been tidied up and a majority of non OCC equipment removed. However, on inspection the following observations were noted:

Some equipment not belonging to OCC still in the garage - angle grinder, bag of football kit, tree climbing equipment, water pump – needs removing – **Action P Loughlin**

Breeze blocks/broken window and wood in garage still hasn't been removed (as per last minutes) – **Action P Loughlin**

Wheelbarrow still required wheel fixing (as per last minutes) – Action P Loughlin

Tub of Hypochlorite in the garage - This is a hazardous substance and requires proper storage – this is an insurance issue and health fire and safety issue – **Action remove - P Loughlin**

Suggested by all Councillors that an inventory list (available from the Clerk) is copied and made available in the garage – **Action Clerk**
