## Context

- Mr. Nick Scott, Managing Direct of Pickstock Homes, presented a pre-application plan for the development of 44 houses on land and off St Mary's Avenue, Overton on Friday 28<sup>th</sup> October 2022. There was a significant response form the community and over 60 were present.

- The pre-application consultation process is a new part of the development management process. Before submitting applications for major developments, developers must now advertise and consult communities for a minimum of 28 days before they submit a planning application.
- Details of the development were shared with the Full Council Meeting on Tuesday 11<sup>th</sup> October 2022 and some immediate questions were addressed
- The developers are required to consult the community and consider the local residents views before submitting a Pre-Application Consultation Report (PAC Report) when they submit the planning application, if a planning application is submitted.

Note: The consultation period ends on the 18th November 2022

## Meeting

- The Chair opened the meeting and Councillors reviewed the process thus far
- The Chair emphasised Councillors must show due diligence during the consultation period and act appropriately
- The Chair proposed a meeting of Council Members with the local community inviting those interested to a meeting in Overton Village Hall on Thursday 10<sup>th</sup> November, 17:30 – 19:30
- The Council would listen carefully and take note of any feedback from those attending the meeting
  Best practice guidance highlights the benefits of engaging with the community to understand their expectations
  and gather views on the development
